I understand that in the event my event does not begin on time due to circumstances beyond my control, E.G.O. Entertainment may extend their scheduled time as long as there is no conflict with previously scheduled engagements on their behalf and will be at the discretion of the owner. I understand and agree that I am able to cancel my booking within 14 days of signing the agreement for a refund minus the \$50 booking fee. I understand that in the event I cancel after the 14-day period, I am not subject to a refund I understand that in the event a lock down is ordered due to COVID, I am able to transfer my payment to a rescheduled date or transfer my payment to a virtual package, at which time, E.G.O. Entertainment will provide services virtually. I understand I will receive an invoice for the balance due and my event will not be booked until payment has been received.
