I understand that I am able to upgrade or downgrade my sponsorship at any time before the next 30 days of payment is due and must give notice of the change via email at least 2 weeks prior. I understand that I am able to cancel sponsorship any time after the first 90 days of becoming a sponsor. I understand this allows me to establish a good response from listeners by keeping my brand in rotation consistently for at least a minimum of 90 days. I understand that if I choose to cancel my sponsorship before the first 90 days, I will be charged a \$20 cancellation fee. I understand I must give a 30-day notice via email before cancelling sponsorship for scheduling purposes or a \$35.00 fee will be assessed. I understand that moving forward, sponsorship fees are due between the 1st and 3rd of the month and my account will be charged during that period. I understand that if payment arrangements have not been made to pay after the due date previous to the due date and payment is received late, a late fee of \$15 will be assessed. I understand that all invoices will include a 3.5% transactions processing fee.

I understand I must provide all videos, pictures, logos, flyers, links and information needed for my ad by the deadline provided to me. I understand I must provide original and/or approved used content, including pictures, for my ads. I understand the content, including pictures, I submit must be owned by me or approved by whatever third party I have received the content from. I understand I must include proper citing of any content I submit in the event it is not my own and requires citation to be used. I understand that I must not provide copyrighted or royalty content, including pictures, that have not been purchased by me accompanied by a commercial license with radio advertisement allowance. I understand that in the event I have submitted content, including pictures, that prove to be copyrighted and not royalty free that result in E.G.O. ENTERTAINMENT NETWORK acquiring a fine, I will be solely responsible for paying the fine and will be responsible for any and all further consequences and liabilities. By signing this contract, I understand that E.G.O. ENTERTAINMENT NETWORK, its affiliates, staff, and other parties are not liable in part or whole for any and all legal or personal action taken against my content submitted for advertising.

I understand that I am able to cancel my ad within 24 hours of securing my ad and that I will not be able to receive a refund for my ad placement after the deadline due to all information given going directly into production. I understand that I must provide a signed agreement before payment can be received. I understand that I must make a payment in full for the package I have chosen within 24 hours of my returned agreement or my spot will be forfeited.

I understand that in the event my ad does not acquire sales, I will not receive a refund of any kind. I understand and agree that the terms of this agreement are valid and legally binding, individually, and as a whole.
