Entertainment Network and understand the features of the package for which I have chosen. I understand that full payment is due before the airing of my content. I understand that I am able to cancel my purchase within 24 hours. I understand that I will not be able to receive a refund for my purchase after the deadline due to all information given going directly into production. I understand that all invoices will include a 3.5% transactions processing fee. I understand that I am able to upgrade or downgrade at any time before the next 30 days of payment are due after my probation period and must give notice of the change via email at least 2 weeks prior to my scheduled payment date. I understand that I am able to cancel my content any time after the first 90 days of purchase. I understand the 90-day period is necessary to begin building a core audience for my content. I understand that if I choose to cancel my content before the 90-day period, a cancellation fee of \$75 will be assessed. I understand that if my due date has passed and I decide to cancel after payment has already been a made, a refund will not be given for that month.

I understand I must give a 30-day notice via email before cancelling to allow notification to audiences and for scheduling purposes or a \$30.00 fee will be assessed. I understand that moving forward, fees are due between the 1st and 3rd of the month or the date arranged by management and will be set as a recurring charge until cancellation. I understand that if payment arrangements have not been made to pay after the due date previous to the due date coming present and payment is received late, a late fee of \$20 will be assessed and my content will not air until payment has been made. I understand that if payment arrangements are made to pay after the due date, my show will not air until that payment arrangement has been met.

I understand that I must call at least 3 to 24 hours in advance to cancel my LIVE content and ask for a replay unless there is an emergency at the last minute should I not be able to broadcast during my scheduled time. I understand that if I do not call within the allotted time my content will be subject to a replay for that day or other content will be aired in its place should I not have ample enough content to air.

I understand that my content is subject to termination (if I refuse to follow the guidelines of content) without refund in the event I violate the rules or standards of EGO TV.

I understand I must provide all videos, pictures, logos, flyers, links and information needed for my ad by the deadline provided to me. I understand I must provide original and/or approved used content, including pictures, for my ads. I understand the content, including pictures, I submit must be owned by me or approved by whatever third party I have received the content from. I understand I must include proper citing of any content I submit in the event it is not my own and requires citation to be used. I understand that I must not provide copyrighted or royalty content, including pictures, that have not been purchased by me accompanied by a commercial license with radio advertisement allowance. I understand that in the event I have submitted content, including pictures, that prove to be copyrighted and not royalty free that result in E.G.O. ENTERTAINMENT NETWORK acquiring a fine, I will be solely responsible for paying the fine and will be responsible for any and all further consequences and liabilities. By signing this contract, I understand that E.G.O. ENTERTAINMENT NETWORK, its affiliates, staff, and other parties are not liable in part or whole for any and all legal or personal action taken against my content submitted for advertising.

I hereby give permission to E.G.O. Entertainment Network and all of its divisions, shows, producers, hosts, writers (and the like), and marketing affiliates to use my personal image(s) and content (videos, films, trailers, audio, etc.) in whatever medium deemed appropriate by E.G.O. Entertainment Network for any of the following purposes: television and radio broadcasting, on-demand streaming, advertising, marketing, public relations, training, and education. E.G.O. Entertainment Network will not use the content for any other purposes. I understand that my consent is voluntary and I release and discharge E.G.O. Entertainment Network owner, employees, and each and all persons involved in creating my personal image(s) from any liability connected with the taking, recording, streaming, broadcasting, advertising, filming, or publication of said interviews, photographs, slides, computer images, videos, or voice recordings.
